## Be A Responsible Pet Owner

- 1 - Register your dog with the Municipality on an annual basis.
- 2 - Do not allow your dog to bark persistently.
- 3 - Have your dog vaccinated against rabies.
- 4 - Do not allow your dog to attack or bite another domestic animal or person.
- 5 - Always keep your dog leashed when off the property of it's owner.
- 6 - Do not allow your dog to run at large.
- 7 - Do not allow your dog to trespass on private property.
- 8 - Always pick up your dog's feces.
- 9 - Provide regular care and attention to your dog.
- 10 - Have your dog spayed or neutered.

*\*1 thru 8 are required by law and non-compliance could result in prosecution\**

**Dog licence fees are as follows:**

**Each dog \$15.00**

**Kennel Licence \$125.00**

Please note: Licence fees are normally doubled after March 31<sup>st</sup> of each year, if you acquire a dog after March 31, you will be required to submit proof of acquisition after that date (receipt of purchase, etc.) to qualify for the early tag fee.

***Puppies qualify for the early tag fee for the entire year of their birth.***
