



**MUNICIPALITY OF NORTH GRENVILLE
NOTICE OF PUBLIC MEETING CONCERNING
A PROPOSED ZONING BY-LAW AMENDMENT**

TAKE NOTICE that the Corporation of the Municipality of North Grenville will hold a public meeting on **MONDAY, JULY 6th, 2015 at 7:00 pm** at the North Grenville Municipal Centre (**285 County Road 44**) to consider the following item:

A proposed Zoning By-law Amendment, File # ZBA-6-15, under Section 34 of the Planning Act, R.S.O., 1990, as amended will be considered at that time.

The purpose of this application is to amend the zoning on Equinelle Drive, Part of Lot 25, Concession 1, from Rural (RU) to Residential – First Density – Special Exception (R1-19) and Tourist Commercial (C7) to permit single-detached dwellings and a golf course pathway to be developed on the subject lands. The same lands are the subject of an existing application under the *Planning Act* for a Plan of Subdivision (File No. 07-T-13005).

TAKE NOTE that having received the application for this zoning amendment the Municipality has deemed it to be complete on June 16, 2015.

ANY PERSON may attend the public meeting and/or make written or oral submissions either in support of or in opposition to the above item. In the event that you are unable to attend the meeting but wish to submit written comments, please ensure that your comments are delivered to the Planning and Building Department's office (285 County Road #44) prior to the day of the meeting.

IF A PERSON OR PUBLIC BODY does not make oral submissions at a public meeting or make written submissions to the Municipality of North Grenville before the by-law is passed, the person or public body is not entitled to appeal the decision of the Council of the Corporation of Municipality of North Grenville to the Ontario Municipal Board or may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.

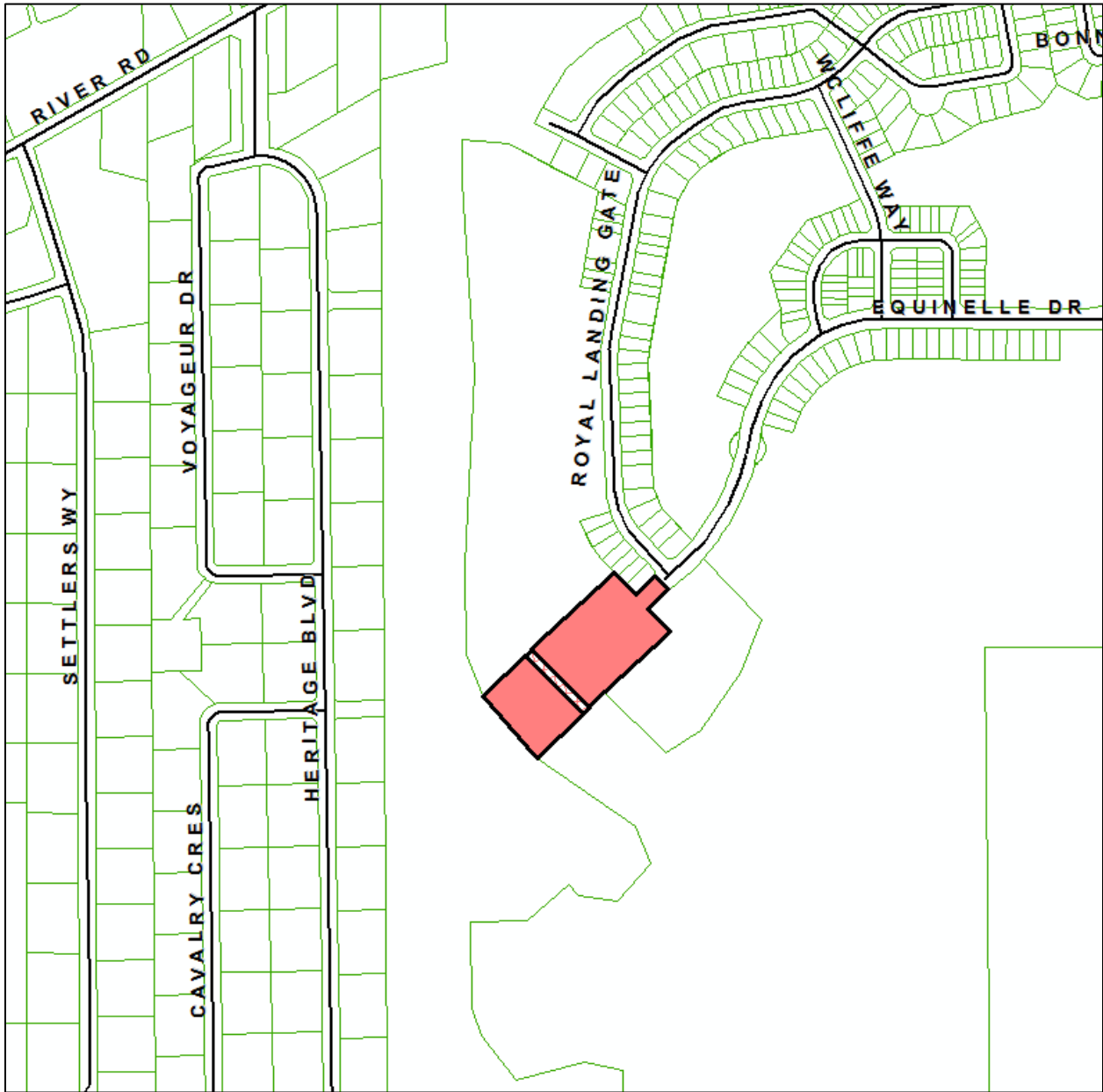
